II. COURSE DESCRIPTION AND PREREQUISITE(S):

The doctoral dissertation is the culminating experience of the Doctor of Education degree involving a scholarly inquiry into an area of professional and intellectual interest. The student will conduct research and complete a report of the findings in the form of a written and oral defense of the research. Students enroll in this course until they have successfully defended their dissertation. This course may be repeated for a total of nine (9) hours. Graded Pass/Fail.

Prerequisite(s): Completion of ADM 930 and approval of the Dissertation Proposal

- A. complete data collection procedures for individual dissertation study;
- B. complete data entry and statistical applications in SPSS;
- C. analyze data from individual dissertation and complete Chapter 4: Results;
- D. provide insights, limitations, and recommendations for further study in Chapter 5: Discussion;
- E. complete final revisions of Dissertation;
- F. successfully defend Dissertation to faculty committee; and
- G. submit manuscript for publication.

Signature Assignment: Students must successfully complete and defend their dissertation, complete the appropriate paperwork for graduation and submit the final dissertation for publication as directed in the Murray State University *Ed.D. Dissertation Handbook*.

X. ACADEMIC HONESTY POLICY:

Fabrication and Falsification - Intentional alteration or invention of any information or citation in an academic exercise. Falsification involves changing information whereas fabrication involves inventing or counterfeiting information.

Multiple Submission - The submission of substantial portions of the same academic work, including oral reports, for credit more than once without authorization from the instructor.

Plagiarism - Intentionally or knowingly representing the words, ideas, creative work, or data of someone else as one's own in any academic exercise, without due and proper acknowledgement.

Instructors should outline their expectations that may go beyond the scope of this policy at the beginning of each course and identify such expectations and restrictions in the course syllabus. When an instructor receives evidence, either directly or indirectly, of academic dishonesty, he or she should investigate the instance. The faculty member should then take appropriate disciplinary action.

Disciplinary action may include, but is not limited to the following:

- 1) Requiring the student(s) to repeat the exercise or do additional related exercise(s).
- 2) Lowering the grade or failing the student(s) on the particular exercise(s) involved.
- 3) Lowering the grade or failing the student(s) in the course.

If the disciplinary action results in the awarding of a grade of E in the course, the student(s) may not drop the course.

Faculty reserve the right to invalidate any exercise or other evaluative measures if substantial evidence exists that the integrity of the exercise has been compromised. Faculty also reserve the right to document in the course syllabi further academic honesty policy elements related to the individual disciplines.

A student may appeal the decision of the faculty member with the department chair in writing within five working days. Note: If, at any point in this process, the student alleges that actions have taken place that may be in violation of the Murray State University Non-Discrimination Statement, this process must be suspended and the matter be directed to the Office of Equal Opportunity. Any appeal will be forwarded to the appropriate university committee as determined by the Provost.
