To examine, in theory and practice, issues in behavioral management, which affect behavior change within various school/clinical settings, and to learn techniques applicable to the process of behavior change.

In particular, the focus will be on teaching, demonstrating, and implementing common models of behavioral change, including functional behavioral analysis, reinforcement theory, token economies, systematic desensitization, and behavioral contracting.
