I. TITLE: Practical Applications in French

II. COURSE DESCRIPTION AND PREREQUISITE(S):

Students advance their speaking, writing, reading, and listening skills in this interactive course focused on the practical application of the language in contemporary French-speaking countries. Students relate experiences, do brief reports on course topics, read stories, watch short films, do role plays, and express opinions concerning a variety of themes. Students learn to communicate on a more complex level in French. Taught in French. Prerequisite: FRE 201 or equivalent.

III. COURSE OBJECTIVES:

The student will

- a) have a solid foundation in all major structures of the French language;
- b) possess an active vocabulary for Intermediate* speech production as well as expanded passive knowledge of additional vocabulary for listening and reading comprehension;
- c) be able to understand Intermediate* level spoken French at normal conversational speed;
- d) be able to express him/herself in writing complete sentences in French;
- e) be able to read and understand a variety of Intermediate* level texts, including some authentic texts (i.e., texts written by a native speaker for a native speaker audience);
- f) be able to speak with appropriate pronunciation and intonation for the Intermediate* level;
- g) to improve students' understanding of the grammar, structure, and vocabulary of English;
- h) to improve interpersonal communication skills, whether English or French;
- i) and to increase and refine students' awareness and appreciation of Francophone peoples and their cultures.

*Please refer to the American Council on the Teaching of Foreign Languages Proficiency Guidelines for specific criteria for "Intermediate Level."

For Education Certification students, this course addresses content topics found in the PRAXIS examination FRE 0171 and 0173.

IV. CONTENT OUTLINE:

This course addresses the following Kentucky Core Content: SS-E/M/H 2.1.1 through 2.2.1. We will cover chapters 4-9; chapters 4 and 8 will be covered only partially.

V. INSTRUCTIONAL ACTIVITIES:

- 1. Class sessions will be conducted in French as much as possible.
- 2. Class periods may include introduction of new material, question and answer practice, brief dialogues in pairs or discussions of outside materials, group compositions, or homework checks.
- 3. Students are expected to prepare assigned material <u>before</u> every class period. Pay special attention to vocabulary; practice and review during each chapter.
- 4. Homework is to be done for each class and will be collected for grading on a random, selective basis; online listening and writing exercises will be assigned for each chapter. Use the tab Websam on vhlcentral.com to find the due dates for IMAGINEZ, 2nd edition.
- 5. Assignments will not be accepted late unless by prior arrangement.

VI. FIELD, CLINICAL, AND/OR LABORATORY EXPERIENCES:

Opportunities for cultural events will be announced during the course. There will be at least one French film shown in the Cinema International series; check for other "soirees de cinéma" as the semester progresses. Three French coffee hours count as one cultural event. Two reports on French related cultural events will be required.

Resources include the Language and Culture Lab (Room 403) which holds audio and computer language aids, as well as a printer. Students are expected to listen to online exercises and practice speaking skills outside of class. Another good source of language immersion will be Cinema International film showings at the Curris Center. Additionally, the Media Center of the Library has a good collection of French films with subtitles. *La table française* is a great way to practice listening comprehension and speaking skills every week. The more you listen, the more you'll learn.

IX. ATTENDANCE POLICY:

When an instructor receives evidence, either directly or indirectly, of academic dishonesty, he or she should investigate the instance. The faculty member should then take appropriate disciplinary action.

Disciplinary action may include, but is not limited to the following:

- 1) Requiring the student(s) to repeat the exercise or do additional related exercise(s).
- 2) Lowering the grade or failing the student(s) on the particular exercise(s) involved.
- 3) Lowering the grade or failing the student(s) in the course.

If the disciplinary action results in the awarding of a grade of E in the course, the student(s) may not drop the course.

Faculty reserve the right to invalidate any exercise or other evaluative measures if substantial evidence exists that the integrity of the exercise has been compromised. Faculty also reserve the right to document in the course syllabifurther academic honesty policy elements related to the individual disciplines.

A student may appeal the decision of the faculty member with the department chair in writing within five working days. To do this, however, you must have taken the placement exam, you must receive either an A or B as a semester grade in 202, and you must file an application with the Dept. of Modern Languages.
