I. TITLE: Matrix Theory and Linear Algebra

II. COURSE DESCRIPTION AND PREREQUISITE(S): The algebra of matrices and its application to problems in Euclidean spaces and elementary linear transformations.

Prerequisite(s): MAT 308.

III. COURSE OBJECTIVES:

Linear algebra is one of the essential pillars of mathematics. Its powerful tools are applied in virtually every area of mathematics, science, and engineering. A strong foundation in linear algebra is essential for success in every scientific endeavor. The central problem of linear algebra is to solve linear equations. At the end of this course students should be able to

- A.** demonstrate a theoretical, operational, and graphic understanding of vector spaces and linear transformations;
- B.** examine some elementary properties of matrices and determine the dimension and structure of some matrices;
- C.** analyze systems of linear equations and determine if any solutions exist.
- D.** solve systems of linear equations with matrices;
- E.** understand the equivalence between matrices and linear transformations.
- F.** work with vectors: linear independence and span; and
- G.** determine and use eigenvalues and eigenvectors.

Plagiarism - Intentionally or knowingly representing the words, ideas, creative work, or data of someone else as one's own in any academic exercise, without due and proper acknowledgement.

Instructors should outline their expectations that may go beyond the scope of this policy at the beginning of each course and identify such expectations and restrictions in the course syllabus. When an instructor receives evidence, either directly or indirectly, of academic dishonesty, he or she should investigate the instance. The faculty member should then take appropriate disciplinary action.

Disciplinary action may include, but is not limited to the following:

- 1) Requiring the student(s) to repeat the exercise or do additional related exercise(s).
- 2) Lowering the grade or failing the student(s) on the particular exercise(s) involved.
- 3) Lowering the grade or failing the student(s) in the course.

If the disciplinary action results in the awarding of a grade of E in the course, the student(s) may not drop the course.

Faculty reserve the right to invalidate any exercise or other evaluative measures if substantial evidence exists that the integrity of the exercise has been compromised. Faculty also reserve the right to document in the course syllabi further academic honesty policy elements related to the individual disciplines.

A student may appeal the decision of the faculty member with the department chair in writing within five working days.
