I. TITLE: Advanced Calculus I

II. COURSE DESCRIPTION AND PREREQUISITE(S): A rigorous development of one variable calculus including limits, continuity, differentiation, integration and sequences of functions.

Prerequisite(s): MAT 309 and 312

- B. be able to read a “proof” and determine whether or not it is valid;
- C. be able to construct valid and clear proofs of their own;
- D. know the basic definitions surrounding the topics mentioned in (II) and (III) above;
- E. know the theorem statements of core theorems surrounding the topics above;
- F. recognize certain classical arguments and be able to reproduce them when necessary (these will be pointed out in class); and
- G. have a conceptual feel for the core concepts of suprema, infima, limits, and continuity.

Plagiarism - Intentionally or knowingly representing the words, ideas, creative work, or data of someone else as one's own in any academic exercise, without due and proper acknowledgement.

Instructors should outline their expectations that may go beyond the scope of this policy at the beginning of each course and identify such expectations and restrictions in the course syllabus. When an instructor receives evidence, either directly or indirectly, of academic dishonesty, he or she should investigate the instance. The faculty member should then take appropriate disciplinary action.

Disciplinary action may include, but is not limited to the following:

- 1) Requiring the student(s) to repeat the exercise or do additional related exercise(s).
- 2) Lowering the grade or failing the student(s) on the particular exercise(s) involved.
- 3) Lowering the grade or failing the student(s) in the course.

If the disciplinary action results in the awarding of a grade of E in the course, the student(s) may not drop the course.

Faculty reserve the right to invalidate any exercise or other evaluative measures if substantial evidence exists that the integrity of the exercise has been compromised. Faculty also reserve the right to document in the course syllabi further academic honesty policy elements related to the individual disciplines.

A student may appeal the decision of the faculty member with the department chair in writing within five working days.
