I. TITLE: Mathematical Statistics I

II. COURSE DESCRIPTION AND PREREQUISITE(S): Introduction to probability theory and statistical inference. Combinatorics, conditional probability, independence. Discrete and continuous random variables and their distributions. Expected value and moments of distributions. Estimation theory and properties of point estimators. Confidence intervals. Basic theory of hypothesis testing. Testing means and proportions. T-tests. Descriptive statistics.

Prerequisite(s): MAT 309 or permission of instructor

- **B.** be able to perform statistical calculations and to understand the theory behind such calculations:
- C. understand the concept of variance and its importance in statistical analysis; and
- **D.** have the ability to understand the concepts of statistical reasoning and to judge the quality of statistical information presented by others.

When an instructor receives evidence, either directly or indirectly, of academic dishonesty, he or she should investigate the instance. The faculty member should then take appropriate disciplinary action.

Disciplinary action may include, but is not limited to the following:

- 1) Requiring the student(s) to repeat the exercise or do additional related exercise(s).
- 2) Lowering the grade or failing the student(s) on the particular exercise(s) involved.
- 3) Lowering the grade or failing the student(s) in the course.

If the disciplinary action results in the awarding of a grade of E in the course, the student(s) may not drop the course.

Faculty reserve the right to invalidate any exercise or other evaluative measures if substantial evidence exists that the integrity of the exercise has been compromised.
