I. TITLE: Special Education Procedures and Strategies for IECE

II. COURSE DESCRIPTION AND PREREQUISITE(S):

Students will develop skills in writing Individual Education Programs and Individualized Family Service Plans. Students will be introduced to relevant special education legislation, laws and policies. Students will develop skills in matching intervention strategies to the strengths and needs of young children with disabilities and their families. Students will acquire skills in the development and implementation of the Individual Education Program and the Individualized Family Service Plan in a variety of settings. Field experiences required.

Prerequisite(s): none

III. COURSE OBJECTIVES:

Class activities will be centered on the attainment of the course objectives listed below. Following each objective, and enclosed in parentheses, are numbers that reference the Kentucky IECE Teacher Standards for Preparation and Certification (IECE), National Association for the Education of Young Children (NAEYC), Council for Exceptional Children (CEC) and InTASC Standards addressed by that objective. Upon successful completion of this class, students will be able to

- A. demonstrate knowledge of state and federal special education regulations related to assessment, development of an Individual Education Program (IEP) or Individualized Family Service Plan (IFSP), and ongoing evaluation of child and family progress; (IECE I, II, III, IV), (NAEYC 3), (CEC 4,7), InTASC 5)
- B. demonstrate the ability to summarize child and family strengths and needs identified on the IEP or IFSP; (IECE IV, VIII), (CEC 4,7)
- C. demonstrate the ability to assess and redesign outcomes in order to meet the ever-changing needs of the child and family; (IECE I, IV, VIII), (CEC 4,7)
- D. demonstrate the ability to make data-based decisions to modify child and family outcomes and intervention priorities and practices; (IECE I, III, IV, IX) (CEC 4,7)
- E. demonstrate the ability to function as a member of a team for the selection of intervention priorities and determining child and family progress in each priority area; (IECE VI), (CEC 4,7)
- F. demonstrate knowledge of state and federal special education policies and procedures as well as recommended best practices; (IECE III, IV, VII), (CEC 4,7)
- G. demonstrate knowledge of the policy development process and contexts (laws, regulations) as well as key players at the federal, state and local levels; (IECE VII) (CEC 4,7)

- H. demonstrate knowledge of skills needed for working collaboratively within and across systems that deal with children and families and with professionals from diverse disciplines; (IECE VI, VIII), (NAEYC 2,3), (CEC 7), (InTASC 10) and
- I. demonstrate the ability to design and implement child and family intervention plans in a variety of settings (home-based, child-care, Early Head Start, Head Start, public preschool and kindergarten) (IECE I, II, III, VI, VIII), (NAEYC 2,3), (CEC 7)

The College of Education Theme of Educator as a Reflective Decision-Maker is addressed in this course by requiring students to reflect on strategies for helping young children with disabilities make progress on the early childhood standards and early childhood curriculum, reflect on diversity through readings and discussions related to family centered services, IFSP experience, and reflect on assessment methods through class assignments and readings.

The EPSB Themes of Diversity, Assessment, and Closing the Achievement Gap are explored through readings, web sites, discussion board, and course assignments.

A variety of instructional activities will be used in this course including online discussion, case studies and simulations, individually developed goals and activities, internet activities, assigned in and out of class activities. Graduate students will extend knowledge through additional assignments and group leadership expectations.

VI. FIELD, CLINICAL AND/OR LABORATORY EXPERIENCES: Students will complete a graduate project with child with disability outside class.

VIII. EVALUATION AND GRADING PROCEDURES

Reflection required for requirements A- C

- A. Complete a Functional Behavioral Assessment and develop a Positive Behavioral support Plan for a young child with challenging behaviors. Work collaboratively with family and classroom teacher and therapists, and preschool or kindergarten age child to complete this project. Requirements for this project will be shared when this topic is covered in the course. (50 points) OR

Develop and submit for grading materials/activities designed to assist parents through transition from Part C to preschool Part B services. You should submit your materials to 2 parents for feedback as part of the draft process and should share parent feedback when submitting the project for grading. (50 points)

- B. Complete one professional growth goal related to the focus of this class (case law and special education practices, and services for young children with disabilities). This is an individually developed goal based on your skills and knowledge. Suggested activities include developing and implementing naturalistic monitoring methods on child's IEP or IFSP, shadowing a First Steps provider observing home visit with child or IFSP meeting, embedding IEP goals into child initiated learning such as the project approach. **If you have not had the experience of participating in an IEP or IFSP meeting, you should select this as your growth activity. This would not be an acceptable goal for graduate students who have had this experience.** You need to submit your goal to the instructor for approval early in the semester before you begin to work on the goal. At the end of the semester, students will submit documentation of progress toward the goal. (worth 25 points)

- C. Participate as a member of an IEP team. Team will use a case study to develop the IEP. Teams will also identify appropriate activities and strategies for implementing the IEP. (worth 50 points for each participant)
- D. Participate in all class activities. Periodically required activities will be worth participation points.
- E. There will be 3 exams each worth 50 points.

The following scale will be used for determining course grade:

A=92-100% of total points

B=91-83% of total points

C=82-74% of total points

D=73-65% of total points

E=below 64% of total points

IX. ATTENDANCE POLICY:

X. ACADEMIC HONESTY POLICY:

Murray State University takes seriously its moral and educational obligation to maintain high standards of academic honesty and ethical behavior. Fabrication and Falsification - Intentional alteration or invention of any information or citation in an academic exercise. Falsification involves changing information whereas fabrication involves inventing or counterfeiting information.

Multiple Submission - The submission of substantial portions of the same academic work, including oral reports, for credit more than once without authorization from the instructor.

Plagiarism - Intentionally or knowingly representing the words, ideas, creative work, or data of someone else as one's own in any academic exercise, without due and proper acknowledgement.

Instructors should outline their expectations that may go beyond the scope of this policy at the beginning of each course and identify such expectations and restrictions in the course syllabus. When an instructor receives evidence, either directly or indirectly, of

academic dishonesty, he or she should investigate the instance. The faculty member should then take appropriate disciplinary action.

Disciplinary action may include, but is not limited to the following:

- 1) Requiring the student(s) to repeat the exercise or do additional related exercise(s).
- 2) Lowering the grade or failing the student(s) on the particular exercise(s) involved.
- 3) Lowering the grade or failing the student(s) in the course.

If the disciplinary action results in the awarding of a grade of E in the course, the student(s) may not drop the course.

Faculty reserve the right to invalidate any exercise or other evaluative measures if substantial evidence exists that the integrity of the exercise has been compromised. Faculty also reserve the right to document in the course syllabi further academic honesty policy elements related to the individual disciplines.

A student may appeal the decision of the faculty member with the department chair in writing within five working days. Note: If, at any point in this process, the student alleges that actions have taken place that may be in violation of the Murray State University Non-Discrimination Statement, this process must be suspended and the matter be directed to the Office of Equal Opportunity. XII. FLAG SYSTEM/ CONTINUOUS ASSESSMENT:

Student progress is continuously assessed throughout the teacher preparation program. Appropriate professional characteristics and demeanors, in addition to academic achievement, are assessed. Positive and negative flags are submitted by faculty to Teacher Education Services and then presented to admissions committees. Negative flags are carefully reviewed to make a determination as to whether a student should be denied admission OR if a professional development plan will be designed for the student's progress towards program completion. **NEGATIVE FLAGS MAY BE GROUNDS FOR DENIAL OF ADMISSION TO TEACHER EDUCATION AND/OR STUDENT TEACHING.**
